

AGREEMENT for ACADEMIC COOPERATION AND EXCHANGE
between
GRADUATE SCHOOL OF SCIENCE AND ENGINEERING, TOYO UNIVERSITY
and
FACULTY OF SCIENCE, CHIANG MAI UNIVERSITY

(Effect)

Article 1: Graduate School of Science and Engineering, Toyo University in Japan and Faculty of Science, Chiang Mai University in Thailand have entered into this Agreement in recognition of the mutual benefits accruing to their academic communities from the establishment of strong international links.

(Purpose)

Article 2: The purpose of this Agreement is to contribute toward the development of research and education of both institutions through their academic collaboration.

(Content of Agreement)

Article 3: For the purpose of this Agreement, the general areas of interest to partners are collaboration and exchange of knowledge in the areas of common interest as follows:

- a. Exchange of faculty members and students for study and research;
- b. Execution of joint research projects;
- c. Exchange of information and academic publications; and
- d. Other programs acceptable to both parties.

(Responsibility for Costs)

Article 4:

- a. This Agreement will not give rise to any financial obligation by one Partner to the other and each Partner will bear its own cost and expenses in relation to the academic activities under this Agreement.
- b. Notwithstanding the provision of Article 4.a, the Partners agree to discuss and further negotiate before implementing any specific academic or research program(s) on specific budget.

(Validity Period)

Article 5: This Agreement will become effective from the date when both institutions shall have affixed their signatures to it, and shall be valid for an initial period of five (5) years. This Agreement shall be automatically extended for another five (5) years and the same rule shall apply thereafter unless either partner gives written notice of

termination to the other party no later than six (6) months before the expiry date.

(Revision)

Article 6: This Agreement shall be amendable by mutual negotiation, six (6) months prior to the expiration, when the amendment is based upon the proposals of operation representatives of either university. The validation date of the revised Agreement shall be the day of its signature by both representatives of the universities. If any of the activities specified in Article 3 is to be affected by the aforementioned revision, the current Agreement shall continue to apply for those activities.

(Termination)


Article 7: This Agreement shall be terminated by either party giving written notice of termination to the other party not less than six (6) months before the expiry date.

(Original Document Protection)

Article 8: This Agreement is signed in two copies in English. Each party to the Agreement shall retain one copy.


